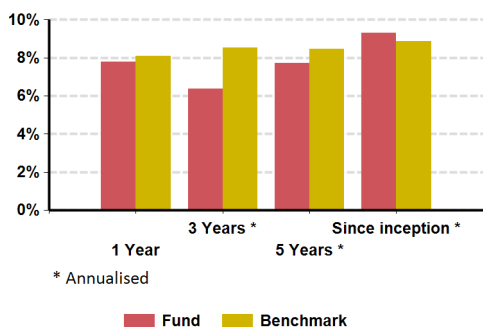

INVESTOR PROFILE

This fund is suitable for conservative investors with an investment time horizon of between 1 and 3 years who wish to have their fund managed to a specified real return target with appropriate risk controls.

APPLICATION

The Mi-Plan IP Inflation Plus 3 Fund is a risk-managed balanced portfolio comprising a range of domestic and foreign asset classes. The fund also forms part of Mi-Plan's range of risk-controlled portfolios in a time-based process designed to integrate the portfolio construction or asset allocation framework with our proprietary financial planning software called MI-PLAN.

OBJECTIVE

The portfolio will follow a conservative investment approach with its primary objective being to obtain a return of at least CPI Plus 3% per annum over a rolling three-year period. The investment manager will aim to achieve a return of at least CPI over rolling 12 month periods.

Local bonds had a cash-like return in September, rising 0.6 percent. Inflation-linked bonds had a positive month but lower than a cash return at 0.4 percent. On the other hand, South African equities came under pressure in September as with equities across emerging markets in general. The SWIX total return was a negative 4.5 percent. In US dollars, MSCI SA had a negative total return of 1.9 percent which was a weaker outcome than the broader MSCI EM which was down 0.5 percent. Currency was not to blame as the rand staged a moderate rally against the US dollar after a particularly weak August. A significant piece of bad news was the release of the second quarter GDP figure which revealed that South Africa suffered a technical recession. While mining shares had a positive month, it is perhaps little surprise that most under pressure were consumer-facing shares including food producers, insurers and healthcare companies whose outlooks were revised down.

While emerging market assets generally struggled – including over the quarter – developed markets were generally up. The main Asian and European markets traded higher, as did the S&P500 in the US although NASDAQ was slightly lower. It remains clear to us that market breadth is thinning and that the prudent thing to do is to fade exposure into the tail end of this multi-year bull cycle.

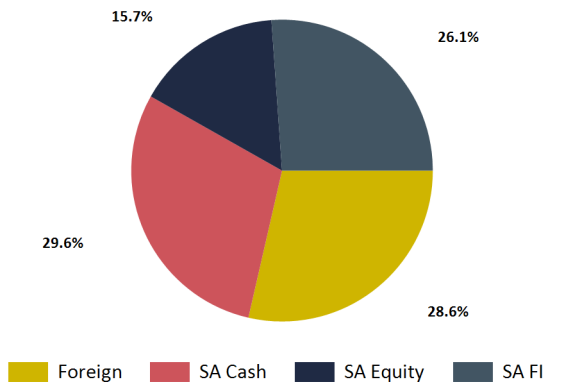

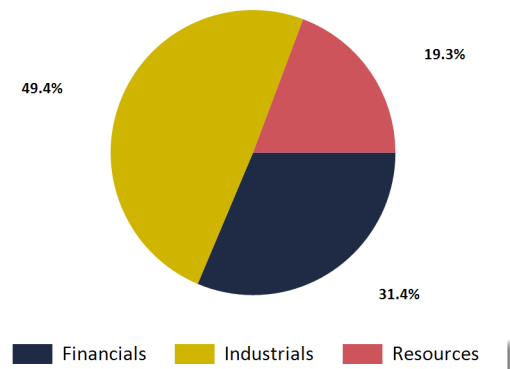
